West Lafayette Village Council met in regular session on February 26, 2024 at 7:00 p.m. in the municipal building with Mayor Jessica Tubbs presiding.

Department Reports:

Fire: No report.

Fiscal Officer: Fiscal Officer, Amy Bourne, reported that Resolution 2024-02 will receive its second reading to request certification of millage from the county auditor in order to renew the Village Current Expense levy that is a 5-year levy for 3 mills, which brings in roughly \$68,000 to the General Fund. Once the certification is received, another resolution will be presented to declare it a necessity to place the renewal levy on the ballot this fall. Ordinance 2024-05 will receive its second reading to regulate trees in the village. The listing of approved trees will be removed from the ordinance and a link will be provided on the website as it is an extensive list and does change. Ordinance 2024-06 will receive its second reading and is to adopt the 2024 version of the Ohio Basic Code. There were a few updates to the listing of additional ordinances to keep in force along with OBC. Resolution 2024-07 is for the annual authorization for the Village to sell obsolete municipally owned property by internet auction during calendar year 2024 and will receive its second reading. Ordinance 2024-08 will receive its second reading that establishes the sewer rates and wording was removed that prohibited sewer taps within a manhole. Each sewer tap permit will be reviewed on a case-by-case basis to make the decision to allow the manhole tap if needed. Ordinance 2024-09 will receive its second reading regarding

the building and zoning codes to modify the wording to the maximum height of accessory structures in the Village in the R-1 district to 20'. Resolution 2024-10 is to authorize the Mayor to apply for a Construction loan for the Sewer Outfall project to complete the necessary funding needed to complete the project and will receive its first reading. The existing Design loan is set up on a 5-year term for \$355,000 with annual payments of \$71,000. The Construction loan will permit the loan to be extended to a 30-year loan, reducing the burden on the Sewer fund with payments of roughly \$17,000. It is requested that the 3 required readings be waived in order to move the project along and meet the December 31, 2024 completion deadline. Resolution 2024-11 is authorizing the Police Chief and Fiscal Officer to apply for a Drive to Succeed Grant through the state that will provide scholarships to Ridgewood Local School students for drivers training classes. The grant application requires that a local unit of government apply for and administer the grant. There will be an application process that will determine the eligibility of the students with the assistance of Ridgewood Local Schools, the Career Center and Coshocton County JFS. Bills were passed around for approval.

Police: No report.

Solicitor: Village Solicitor, Joel Blue, had nothing to report.

Village Administrator: Village Administrator Tammy Hicks reported that Ordinance 2024-12 regarding regulating septage hauling will receive its first reading. The rate for residential hauling will be reduced back down to \$0.02 per gallon in order to match surrounding area charges. No one else in the area takes industrial waste, so that fee will be left at \$0.05 per gallon. There have been 2 recent citations issued for unsightly/unsanitary premises. Approval for the ARC grant was finally received, which was the final piece of funding needed for the Wastewater storm sewer outfall project. Advertising for construction should be done very soon. The Russell Ave. sidewalk project should pick up in the next couple of weeks with the break in the weather. The wastewater treatment plant finished belt pressing the sludge last week to get ahead of the process due to the sewer outfall project beginning soon. There are still ongoing repairs at Fresno and Pearl Valley on the sewer lines with both pumps needing repairs as a result of the type of waste being discharged from Pearl Valley. Thank you to the Street Department for the snow clearing the past couple of weekends on a job well done. Trees for waterworks park will be coming from the Soil and Water Conservation. They will most likely define the perimeter of the Village property.




